

Comments The majority of the subject property falls outside of the Zone A0, Depth 1 foot 100 year flood hazard per the most current FEMA Flood Maps. The portion of the subject property affected by the Zone A0 flood zone is adjacent to the street right of way. At its highest point, the flow line elevation of the curb within the right of way is 1.7 feet below the finished floor of the subject property. The lowest point of the street flow line is 5.0 feet lower than finished floor. Residence is further protected from street borne flood waters by CMU block wall along Ellen Court, NE.



