



COMMENTS: Elevations are based on City of Albuquerque Control Station "20-K19", having an elevation of 5308.69 feet above sea level. Also 5 storm drain Drop Inlets have been installed in front of this property along Grand Avenue.



The diagrams above illustrate the points at which the elevations should be measured in A Zones and V Zones. Elevations for all A Zones should be measured at the top of the reference level floor. Elevations for all V Zones should be measured at the bottom of the lowest horizontal structural member.
